(i) MEMBERSHIP- A member of the General Body is eligible for the membership of the Governing Body.

(ii) MEETINGS- Meetings of the Governing Body shall be held at least once in six months or more if the president thinks necessary. Seven days notice is required for a meeting of the Governing Body. An emergency meeting may be called with one day notice.

(iii) OUORUM- The quorum for a Governing Body meeting shall be 2/3 of the total numbers of the Governing Body. If the meeting has to be postponed due to like of quorum, it will be held after an hour at the same place on the same day. No quorum is required for a postponed meeting.

ILLING UP OF VACANCIES- In the event of vacancy due to iny cause what so ever occurring among the members of the joverning Body (or among the members of the society), the same be filled up by the president of the society, or the president shall delegate any other member in his or their place. The members of the

Governing Body shall be in the position of trustees and of beneficial owners.

(v) TENURE- The tenure of the Governing Body shall be three years, It may also be reconstituted before completing three years, if any member retires or resigns or the president deems it necessary. A member may be nominated to the Governing Body consecutively.

(vi) POWER OF THE GOVERNING BODY- The Governing Body of the society as above constituted shall have full power, subject to the rules of the society to do all such things as are necessary or expedient for the management of the affairs of the society or which in its opinion may be conducive to the attainment of the objects of the society. In particular it may, through the president of the society or his duly authorized agent, sell exchange, mortgage otherwise alienate the property of the society or any part thereof and apply the proceeds in any manner and for such purposes as it thinks to things lit to promoting the objects of the society. It may also borrow and raise in such manner as it shall think, and secure the repayment of any moneys borrowed or raised by the society by mortgaged, charge or lies upon the hole or part of the society's property for assets, and give to lenders or creditors powers of sale and all other usual and necessary powers

10 POWERS, PREVILEGES AND DUTIES OF THE OFFICE BEARERS OF THE GOVERNING BODY:a. THE POWER OF THE PRESIDENT-

The president of the society or his duly authorized agent shall also have power to purchase, endorse, transfer and negotiate in every way securities, stocks and shares of every description of money market for or on behalf of the society. The president of the society or his duly authorized agent shall have power, for or on behalf of the society, to acquire and hold, whether by purchase, lease or otherwise property mountly immovable, or receive any gift whether of money or property movable or immovable whether by gift of the person living or by legacy, bequests or other, for any of the objects of the society. The president shall be the director of all

(a) If it is feit lat any time that the management of the society is far from being progressive and its organization is declining. The Governing Body can authorize the president to take over the entire administration of the institution and run it himself as an ad-hoc measure till the situation brightnes and individual control is not required.

(b)The president in such circumstances can take help from any member, he thinks necessary and expedient in the interest of the society.
